# CERTIFICATION BADGES

Upon certification, you'll have the choice of two badges:

## Option 1



**Standard:** ISO 9001 is used for the above example, however your Certification badges will vary deepening on the ISO standard(s) you've been certified against, such as ISO 27001, ISO 14001 and ISO 45001.

**Option 1:** This version includes the Emirates International Accreditation Centre (EIAC) and United Accreditation Foundation-UAF logo and is therefore subject to the UAF/ EIAC conditions that you must adhere to when using this Certification badge.

**Certification number:** When downloading your certificate badge from your Gabriel Registrar client area, you'll have the option to request that your unique ten-digit Certification number is added to your badge. This will then allow any potential clients of yours to verify your certification with us

RULES OF USE

**Formatting:** The Certification badge and logos within shall be displayed only in the appropriate form at, size and colour as detailed in these Branding Guidelines.

**Changes:** You are not permitted to change the Certification badge’s design or colour in any way.

**Scope:** The Certification badge shall not be used in any way that might mislead the reader about the certified scope of a certified organisation.

**Usage enquiries:** Any use of the Certification badge or official logos that might contravene the conditions laid down in these Branding Guidelines shall be referred to GR.

**Responsibility:** The Certification badge shall not be used in such a way as to imply that GR accepts responsibility for activities carried out under the scope of a client’s certification.

**Condition:** Upon suspension, or termination, of any GR certification, certified organisations shall immediately cease to issue any items displaying the GR Certification badge, this shall include the removal of GR Certification badges displayed on websites, stationery and vehicles

**Products:** Do not display any version of the Certification badge on products, product labels, or product packaging, or in any way that may be interpreted as denoting product conformity.

**Condition:** The Certification badge may only be displayed on condition that:

1. The title or logo of the certified organisation is also shown;
2. The Certification badge has no more prominence than the title or logo of the certified organisation.

## HOW TO DISPLAY YOUR CERTIFICATION BADGE

**Size:** Option 1 of the Certification badge shall have a minimum height of 15mm, any enlargements shall retain the same proportions as those in your original download.

**Colour:** You are not permitted to change the colour of your Certification badge in any way.

**Formatting:** Your Certification badge will be available as a high-resolution JPEG, You may use this for reproduction purposes, however we will supply other version, such as an EPS, Ai, PDF, as changes to the badge design and colours are strictly not permitted.
